Customer is responsible for obtaining permission from the copyright holder pictures, music, logos, etc... included in the project. Customer warrants and represents that they have, or shall obtain, sufficient personal injury and property damage liability insurance with respect to the activities of NP at the place of occasion. A deposit is required and nonrefundable unless NP initiates a cancellation. At the time of the event the remainder of the balance due is expected. Customer understands that under no circumstance is a refund an option after the event has been videographed. Customer shall provide each member of NP with reasonable amounts of free water/beverages during the occasion, tickets to the occasion, and free meals on the date(s) of the occasion. Customer is responsible for reimbursing NP, outside of deposit, for any cost incurred due to cancellation by customer for any reason. Customer authorizes NP to fix the sounds or images or sounds and images of the event in a copy or phonorecord, or reproduce copies or phonorecords of event. Customer gives NP exclusive permission to transmit or otherwise communicate to the public the sounds or images, or sounds and images of the event. Customer gives NP exclusive permission to distribute or offer to distribute, sell or offer to sell, rent or offer to rent, or traffic in any copy or phonorecord fixed as described above, regardless of whether the fixations occurred in the United States. NP does not guarantee playback of the works created by NP on any particular devices. Customer's signature affirms complete understanding and acceptance of all of the above terms.
